Clearing and grubbing has been completed in the Access Road Corridor and erosion and sedimentation controls are in place. And some fills, North of the stream crossing, have been placed. Production blasting for the rock fill material for both the ATCT access road and the Localizer Critical Area has begun. Fill in the Localizer Critical Area is nearly 75% complete. We continue to wait for the release of the DEP permits for the wetland mitigation and the stream crossing.

Plans and specifications for the next phase of construction which will place the fill for the taxiway extension are complete and advertisement has been made for bids. Bid opening is scheduled for March 17th.
