**DIRECTOR'S REPORT**

#### A. Passenger Activity

As noted on the attached "Airport Quick Look" charts, passenger enplanements for the month of April 2023 decreased  $\underline{14.3\%}$  to  $\underline{14,665}$  from  $\underline{17,110}$  in the month of April 2022.

In April 2023,  $\frac{7}{2}$  departing flights were cancelled, all for ATC/Weather. This accounts for  $\frac{426}{2}$  ( $\frac{2.4\%}{2}$ ) out of a total  $\frac{17,888}{2}$  departure seats. Also,  $\frac{8}{2}$  arriving flights were cancelled, all for ATC/Weather

As noted on the attached "Airport Quick Look" charts, passenger enplanements for the month of May 2023 decreased 12.4% to 15,022 from 17,141 in the month of May 2022.

#### Question:

Mr. Frederickson ask why we think American reduced their number of seats in this market. Mr. Beardsley replied that they are changing aircraft type in and out of the market. Sometimes we have the mainline aircraft and other times we have the smaller aircraft. They have been very loyal to AVP and that they will be able to make expansions into our market with a Chicago to Charlotte service.

In May 2023,  $\underline{\mathbf{0}}$  departing flights were cancelled. This accounts for  $\underline{\mathbf{0}}$  ( $\underline{\mathbf{0}}$ %) out of a total  $\underline{\mathbf{17,855}}$  departure seats. Also,  $\underline{\mathbf{0}}$  arriving flights were cancelled.

#### A. General Aviation Operations

For April 2023, General Aviation had <u>961</u> operations (one take-off or one landing) which is an increase of <u>6.3%</u> from April 2022, General Aviation Operations. General Aviation revenues decreased **\$498** or **2%** to **\$20,957**.

For May 2023, General Aviation had  $\underline{1,098}$  operations (one take-off or one landing) which is an increase of  $\underline{0.6\%}$  from May 2022, General Aviation Operations. General Aviation revenues increased \$851 or 3 % to \$27,042.

# A. QTA Facility Update

Mr. Mykulyn updated that Phase 1 (old Verizon building) needed to be worked first so Avis can remain and still function there. This phase is 90% complete. Car Wash installation is 75% complete. The car wash buildings framing has been completed and inspected and drywall is going up this week. Dyed concrete floor finish was completed this week. Electrical conduit & rough in is complete and wiring is in progress. Vacuum and compressed air systems will be completed next week and testing will follow. Exterior doors are hung. Construction trailer is being moved out to allow for more parking for the upcoming Nascar race. Natural gas is the only remaining utility to be installed. Pedestrian sidewalk replacement is currently being priced. Anticipated move in dates for Avis are August 9<sup>th</sup> and the remaining car rentals are targeted for the end of November.

## B. Evergreen Elementary 1st Grade Airport Tour

(Western Wayne School Districts)

This was the first tour since the pandemic. Students drew pictures as a "Thank You" for their experience. There were 75 students which were broke up into two groups. They toured the Terminal Building and the ARFF building. Ambassador Ron Skamanich spoke to the children about the Terminal and Jared Whitaker spoke about the ARFF building and took out the firetruck for them. We deal with other groups as well for tours.

## C. Canadian Wildfires

There was very little impact to flights due to the smoke from the wildfires to date. We will use our website to notify customers in the future if there are any delays or cancelations.
