On the Localizer Critical Area Site Preparation and ATCT Access Road construction – Work is now substantially complete. The Contractor has de-mobilized most of their equipment, punch lists for work remaining have been developed and the work is being reviewed for final inspection. Work remains on the Tower Access Gate as we wait for materials and coordination with the FAA security contractor.

On the Taxiway B Extension Site Preparation - we continue to wait for a grant offer from the FAA and permit amendment approval for the project.

On the Localizer Relocation bid advertisement has been made, pre-bid meeting held and bid opening is scheduled for September 1st.

On the final phase, the taxiway paving, signing and lighting, 60% progress drawings are being reviewed.

Work on the project is underway and the Contractor is working to complete the first of the two in-bound baggage carousels. The work is being phased to maintain passenger services throughout the project. Completion is planned for mid-October.

Preliminary floor plans are being reviewed by the lease tenant. And we are reviewing manufactures for the ambulance station space, which is intended to be a modular design. The TIPS cooperative purchasing program will allow us to work directly with a building manufacturer for design and construction of the station. We will then bid for purchase of the Hangar portion and then bid for site preparation and erection of both portions of the structure onsite. We meet every other week with the consultants to review progress on the design, financing through grants, and schedule of submissions.

By phasing this project, it moves the timeline along and

also saves money.

Mr. Beardsley reported for the month of July 2022, when compared to July 2021, passenger boardings increased 18.2%. Although load factors for July 2021 were at an astounding 95.1%, July 2022 load factors were very strong 90.4%. It should be noted, all of the equipment (seat availability) has since been upgraded, which plays a role in calculations.

Mr. Beardsley also noted significant increases with passengers going through TSA security in the last month, up 4.3 %, as well as public parking increases.
